

Subject: Report on looting, vandalism and burning down of house and household items/assets and Documents.

Madam/Sir,

With reference to the above subject I have the honour to report to you as follows:

1. That I **Songbiakthang Hangsing** aged about 36 years S/o **Chinzatun Hangsing** belonging to the Paite tribe/community recognized under the constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a permanent resident of **New Lambulane, 3rd Street, New Checkon, PO/PS Porompat, Imphal-East**.
2. That at about 2pm on the **27th August 2023**, some unknown miscreants have looted, vandalised, and burnt down our house along with all our household items and some of our Original Documents.
3. That, it may be reported here that the above said criminal activities has caused us grave mental agony and incurred a huge loss, which may be estimated to be **Rs. 2,50,00,000 (Rupees Two Crore Fifty Lakhs)** only.
4. That, me, and my family left our house on the **4th of May 2023** and are currently taking refuge at **Zion Veng, New Lamka, Churachandpur**.

In the given circumstances, I humbly pray you kindly register an **FIR/ZERO FIR**, investigate the matter, and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
