

Subject :- Report on Looting, household items/assets and Documents

Madam/Sir

With reference to the above cited subject I have the honour to report to you as follows :

1. That I Goutinlam Gangte aged about 71 years H/o Khola Gangte Belonging to the Gangte Tribe / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a permanent resident of New Lambulane Riverline Imphal East ,PO/PS- Porompat.
2. That at about 4 pm on the 3rd May 2023, a huge contingent of armed radical meetei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun along Meitei mob numbering about 1500 attacked our locality so me and my family have to run for our life on 6th May and in the process, they have looted, my house as well the house of my son Mr Goutinlam Gangte and one daughter Mrs. Solomi Gangte in the same campus along with our Aactiva two wheeler and some of our Original Documents.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred a huge loss to me as well as my son Soilalmuon and my daughter Salomi which may be estimated to be Rs. 4500000 (Rupees Fourty Five Lakhs) only
4. Fortunately, me and my family managed to escaped from the criminals who even tried to even kill us, and now currently taking refuge at Churachandpur Higher Secondary school Relief Camp at Churachandpur.
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at Churachandpur Higher secondary school Relief camp Churachandpur. And ,thus I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
