

**Subject – Report on crimes of attempt to murder, criminal intimidation, unlawful displacement, vandalism, looting, arson-attack and discrimination of Scheduled Tribes.**

**Dear Madam,**

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the **Zou Tribe**, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**. And, I am a permanent resident of House No.1, Nongpok Inkhol, New Lambulane, P.O. & P.S. Porompat, District- Imphal East, Manipur, bearing **OLD PATTA NO.- 998/1976, NEW PATTA NO.- 912 and CS Dag NO.- 4119**.

That, on the **22<sup>nd</sup> of August, 2023** at about **11:30 PM**, a huge contingent of armed radical belonging to the Meitei/ Meetei community suspected to be members of Arambai Tenggol and Meetei Leepun, looted and vandalized our properties along with the house.

That, it may be reported here that the miscreants were shouting slogans like- **"KANGLEIPAK YAIPHARE"**; **"KUKI HATLO"**; **"HAO HATLO"**; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.

That, it may also be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs.42,25,000/- (Rupees Forty-Two Lakhs Twenty-Five Thousand) Only**.



I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
