



**Subject: Report on the Crimes of Looting, vandalism, arson attack and discrimination of Schedule Tribes.**

Dear Sir/Madam,

The undersigned would like to inform you on the above aforesaid mentioned subject for kind consideration and necessary action.

That, on 2<sup>nd</sup> August 2023 at 10:00 Am. My residence (rented) located at New Lambulane 2<sup>nd</sup> Street, Police Station Porompat Imphal East District, Manipur-795005, was attacked, looted and burned by a group of Meitei/Meeitei Arambai Tenggol, Leepun Group, COCOMI, Citizen Clubs (Wangkhei Checkon), Meira-Paibis State sponsored radical groups.

That, it may be reported here that the miscreant were shouting slogan like -"KANGLEIPAK YAIPHARE", "KUKI HATLO", "HAO HATLO", etc. While they were carrying out their criminal activities. It seem to me that all these has taken place at the instance of the Manipur State Government as the perpetrator openly claimed and shouted that nobody can stop them. Even the police because everyone, including top officials are patronizing them and that no harm could be done to them.

That, it may also be reported here that the criminal broke open my gates(s) and looted every valuable property from rented house, premises worth **Rs: 60,00,000, (Approx), (Rupees Sixty Lakh only)**. They burn down all the remaining things.

That, at the time of attack we somehow managed to escape to save our lives under the compelling circumstance thus could be able to take our belongings including important documents, vehicles, educational certificate etc, apart from tangible materials etc.

That, I am filling this report lately because there is a great danger to my life due to which I was at different places to save my life and now I am able to restore my health and I am settled at a relief centre at **Chiengkonpang Village** and, thus I am filing the complaint today.

Therefore, with utmost respect, I request you to take strong actions against the perpetrators by registering an **FIR** under relevant section of the Indian Penal Code.
