

Subject: Reports of vandalize and looted at Imphal Cannan Veng, North AOC.

Sir/Madam,

I, am a tenant staying at Canan Veng North A.O.C. Imphal, P.O. & P.S. Porompat, Imphal East, was a scheduled tribe belonging to Any Kuki Tribe would like to report that, because of the communal violence between Meitei/Meetei and the Kuki-Zo community that have erupted on the 3rd May 2023 have fled toward Lamka leaving behind my properties and during my absence my rented residence as mentioned above was vandalized, looted and all materials inside like double bed, set of cupboard, Sofa set, Television, Fridge, Washing machine, Computer set, Kitchen Cabinet etc estimated to be at a value of about Rs.900,000/- (Rupees Nine lakhs only) were looted and vandalized by Meitei/Meeteis hooligans on the 15th June 2023 before noon.

It may be mention that my new motor bike was also stolen in this act, details is as given below:
