

Sir,

I have the honour to state that on 4/5/2023 around 10:00am some unknown miscreants belonging to Meitei youth organization suspected to be members of Arambai Tenggol, Meitei Leepun and Kangleipak Kanba Lup (KKL) about 1000 or more members by carrying sophisticated weapons forcefully attacked our colony at Haokip Veng, Imphal East, Manipur.

As a result, they destroyed our house, looted all the valuable household properties and burnt down our houses leaving us homeless. The approximate of non-movable lost and destroyed properties is estimated to be about Rs. 21,50,000/- (Twenty one lakh fifty thousands).

I therefore, pray that you to kindly registered a regular case and take necessary legal action according to law.
