

Subject: Report on arson of residential house.

Sir,

With due respect and honour, I am to report that I am a permanent resident of Chassad Avenue, Imphal East, Manipur.

That, on 29-05-2023 at around 10:00 a.m, my residential wooden building (double-storey) registered in my name under Village & Sheet No. 26(A)-Nongpok Ingkhol, Patta No. 1616(Old) and 772(New), located at Chassad Avenue, Imphal East, PS – Porompat, was trespassed by unknown Meitei miscreants and set on fire my house in which the undernoted properties were burnt down/damaged.

List of properties burnt down/destroyed are as below:

1. 2-storey wooden building (Teak) worth Rs. 50 Lakhs.
2. Furniture set worth Rs. 7 Lakhs.
3. Clothes and other wearing apparels worth Rs. 3,5 Lakhs/-.
4. Jewellery worth Rs. 10 Lakhs /-.
5. Utensils worth Rs. 2 Lakh.
6. Computer set and accessories worth Rs. 1.5 Lakhs.
7. Tools (Electrical, carpentry, Water pump, etc.) worth Rs. 1 Lakh.
8. Scooty bearing R/No. MN06SH-4318 worth Rs. 80,000/-.
9. Water storage (sintex) – 3 in nos. worth Rs. 10,000/-.
10. Electronic gadgets (TV, Fridge, Water Filter, Toys, Inverter, Fan, etc.) worth Rs. 3 Lakhs.
11. Decorative items worth Rs. 20,000/-.

Grand Total – Rs. 79.1 Lakhs.

It is, therefore, requested to take up necessary legal action against the said unknown miscreants. Cause of delay in reporting the incident is due to my displacement and the prevailing law and order situation.
