

Subject: Circulation of news by MAMI TV on social media which can have repercussion on the law and order situation in the State.

Sir,

I am to enclose herewith letter No. IT/12/2023-DITC-DIT dated 6<sup>th</sup> September, 2023 received from Director (IT), Manipur wherein he has forwarded a letter of the Superintendent of Police, Cyber Crime, Manipur enclosing seven url links with a request to take up necessary action to ensure that MAMI TV refrains from such activities till such time that the Government of India takes up appropriate action.

On examination of the URLs, it is found that the contents <https://www.youtube.com/channel/UCnanitvnetwork> and <https://www.youtube.com/watch?v=100f1JgTgE&list=PL41s> have been uploaded by MAMI TV which is located at Angom Colony, Imphal East, Manipur.

Superintendent of Police, Cyber Crime, Manipur, In his letter, has stated that the channels have been circulating sensitive and dubious news on social media particularly in YouTube and Facebook in the midst of the ethnic violence and such posts which can have repercussion on law and order need to be taken down immediately to prevent further escalation of violence. His Office has reported to block or take down the posts to the YouTube intermediary and has requested the IT Directorate to take appropriate action against the YouTube Channels for posting sensitive and dubious news. In this regard, IT department has requested the Ministry of Information and Broadcasting, Government of India to block the channel and take down the post.

Further, this Office has issued prohibitory orders extending to the whole areas within revenue jurisdiction of Imphal East district, under Section 144 of Cr. P. C., vide this Office Order taken up under Cril. Misc. Case No. 8 of 2023 dated 3rd September, 2023 restraining activities which may cause serious breach of peace and disturbance to public tranquility and thereby endanger human lives and properties in the area which include, among others, the spreading of false/fake news and rumour mongering.

It is pertinent to mention here that efforts are being made by all concerned stakeholders to bring peace and normalcy in the State of Manipur and such acts, as reported by SP Cyber Crime, will hamper the coordinated efforts. Such acts, as conducted by MAMI TV, not only incite acts of violence among many people more particularly the youth but also disturb law and order in the district as well as in the State.

As the matter is viewed to be of serious nature, which may cause serious breach of peace and disturbance to public tranquility and thereby endanger human lives and properties in the area, you are requested to take up necessary action under relevant provisions of Act & Rules immediately. Action Taken Report may kindly be submitted to this Office.
