I, Shri D. John residing at Luwanglong Khunou Village, Khoupum, Noney District would like to report a criminal incident involving the accused, Shri Gurumayum Yaima Sharma, which took place on 28/8/2023 at Khurai Thoudam Leikei, Imphal East. I came to Khurai Thoudam Leikai, Imphal East on that fatefully day for official work to meet the Khoupum SDO staff with my vehicle bearing No. MNO 4A3089.

As my vehicle was parked near his residence I was called down at parking on street with arms and criminally assaulted me using abusive language and communally /racially deceitful after puncturing my vehicle tyres. I was not given any opportunity to explain, it was completely unprovoked incident. I pleaded him of my ignorance of the place as I come to visit Khoupum SDO staff.

I am badly injured, no one informed immediately, I went home and consulted elders and Local Hon'ble MLA Nungba AC. Since this time, it is a communally sensitive situation, I was advised follow as per law established to seek your help to give me justice by taking exemplary action against Shri Gurumayum Yaima Sharma as per deem fits instead of going to customary law courts.

Therefore, I would like to request you to take action as per Schedule Tribe atrocities act/ attempt to murder under IPC at the earliest.
