On Uchekon and subsequently shifted to Shillong soon thereafter. Personal belongings of my family and valuable documents including my Training Certificate(Indian Military Academy) and a voter. ID of my mother were looted/burned on the incident. List of items looted/burned on the incident is attached along with.

Therefore, I request you to kindly take necessary action at the earliest please.
