Thus, on 20-07-2023 I got information from one of the security Guard of the office compound that some Meitei/Meetei goon stole my vehicle which was park inside the office compound of Doordarshan Kendra Imphal, Manipur .

It is requested to your good office to make entry of my report a Zero F.I.R for stolen of my said vehicle and issue me the copy of the said report for my reference in future.
