At the very outset, I would like to draw fewline for your information that due to the present situation of ethnic class between Tribal and Valley base Meitei/Meeitei from 03-05-2023, on dated 21-05-2023 at 6:00 pm, a group of group of Meeitei/Meitei's suspected to be members enter the compound of our **Rented Resident of Mission Compound, Checkon P.O & P.S- Porompat & District- Imphal East on 21-05-2023 at 7:00 PM** vandalism, looting and burning down of all my properties which worth Rs. 3,50,000/- (Rupees Three Lakh and Fifty Thousand) only of my property. I was staying in a rented resident for pursuing my study at Imphal. I could not make the said report on time due to present situation in reaching my home town on time which unable me to do the report.

It is requested to your good office to make entry of my report a Zero F.I.R and take action against the perpetrator as per Law and also issue me the copy of the said report for my reference in future. The list of our properties are attached with my present report.
