Subject - Report on crimes of vandalism, looting, criminal intimidation, unlawful displacement and discrimination of Scheduled Tribes.

Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the *Hmar Tribe*, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under the SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis, I and my family deserted our rented house on the 4th of May,2023 at around 9:30PM, located at 3rd Street, EFCI Compound, New Lambulane, *P.O. & P.S.-Porompat*, district- Imphal East. It has come to our knowledge that our deserted house was looted and vandalized on the 8th of June, 2023 at around 4:30PM. And, my cloths shop located at ICI Building Mission Compound, Sajangthong, New-Checkon, whereas, the P.O., P.S. & District falls under the same jurisdiction as my rental house, which was yet to be Opened, as the shop registration and other documents are still pending. And, Since the ethnic crisis erupted, its not possible to return to the valley (Imphal) to live a normal life. And, from some reliable source I came to know that the said newly unopened shop where I stored the goods, was looted and vandalized on the 20th of June,2023 at around 9:30PM.

The criminals who are suspected to be members of *Arambai Tenggol* and *Meetei Leepun*, broke open the door, destroyed and looted every valuable property from the said rental resident and the shop, which in TOTAL is estimated to be worth about *Rs.12,38,900/- (Rupees Twelve Lakhs Thirty-Eight Thousand Nine Hundred)* only.

That, it may be reported here that the miscreants were shouting slogans like- "KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because

which I was at different places to save my life and now I am able to restore my health and I humbly pray you to kindly register a ZERO FIR, investigate the matter and punish the perpetrators as per the thankful to you and obliged. Thus, I am filing the report lately today.
