

Sub: Request for lodging of FIR case regarding looting and
ransacking/burnt down of my house located at Moreh on
28th June 2023.

Sir,

I, the undersigned have the honour to state that large number of
innumerable unidentified group of people belonging to Kuki Community with
deadly weapons and sophisticated arms including kuki militant groups
stormed to all Meitei inhabited areas of Moreh Town on 28th June 2023 at
around 8 am. The said unidentified groups vandalized/burnt down my house
and looted all valuable items. In that unfortunate incident, I have lost a total
amount of Rs. 4700000/- (Rupees Forty-seven lakhs). After the said
unfortunate incident/ mob violent, my family are fleeing from village and my
family is taking shelter at Mongsangei Makha Leikai.

It is, therefore, prayed that the respected sir may kindly initiate and
take necessary legal action(s) against the persons and the persons involved in
the said inhuman acts and heinous crime committed by the accused persons
and persons involved as per law of the land as early as possible.

I shall be grateful for your kind co-operation and necessary action (s).
