



With due respect, I would like to state that I am a temporary residence of New Lambulane 3rd Street staying at rental house. Due to the prevailing law and order situation of Manipur we fled our house on the 4th May of 2023 fearing for our life. On the 27th August of 2023 it came to our notice through social media that 2/3 houses of our neighboring houses were burnt down, of which we are also informed that some of our household items including my office Laptop (HP) provided by CPC, High Court of Manipur has been looted.

It is therefore, requested you to kindly register a case and take necessary legal action.
