

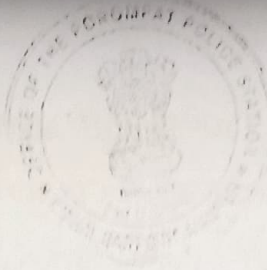

I have the honour to inform you that I am staying in a rented house of NIT building near Brighter Academy, New Checkon, under Porompat-PS, Imphal East. The rented house is belonging to one Meitei Pangal. That on 4th May, 2023 at around 10:00 am a suspected volunteers of Arambai Tenggol, Meitei Leepun along with Meitei militant attacked my rented house and looted all my valuable properties. The looted properties are:

1. One Gas-Stove with two cylinders (2) Three nos. of Syntax (two syntax containing 300 litres, one syntax containing 500 litres. (3) 3 nos. of buckets (4) one brite (4) one Tub (5) 2 nos. of table (6) one Mattres (6) 6 nos. of blankets (7) 2 nos. of tables (8) all my school and college text books (9) 2 nos. of jumbo box (10) one stand-fan (11) one bed (12) 2 nos. of shoe-rack (13) Kitchen items.

The total approximate worth of loss/damaged properties is about 1,20,000/- (One lakh twenty thousand) only. I Therefore, request you to kindly take up a necessary legal action as per the law of the land.
