Sir, I am to state that, on the 3<sup>rd</sup> May evening of 2022 around 7pm our locality, i.e, New-Lambulare (Checked under Pampat Police Station, falling under the revenue of Imphal East was under attacked by thousands of mobs who were unknown miscreants, belonging to the Meitei Community with an intend to kill every Kuki communities living in the Imphal valley.

As a result my house and properties worth crores were destroyed and looted.

And since I was chased away from my own home residence i.e, New Lambulare 3<sup>rd</sup> Street, Imphal East House NO. 23, we had to flee for our lives leaving all our valuable properties. Therefore this has made us homeless having no place to stay or live in as I have no idea or whereabouts my things and papers that I have left now.
