I am to state that on 27<sup>th</sup> August, 2023 (Sunday), at around 3.30 pm, the house at New Lambulane 3<sup>rd</sup> Street, Imphal East (under Porompat PS) that belongs to Shri Chinzatun Hangsing the first floor rented by my sister-in-law Smt Damlawmkim (36) w/o Shri T.S. Thang Goulian (36) (presently staying in Guwahati). was looted and burnt by suspected meitei miscreants in the wake of the recent ethnic violence that started on 3<sup>rd</sup> May, 2023.

2. In the incident, the following household items of approximate value of Rs 8, 49, 000 were looted/ burnt:

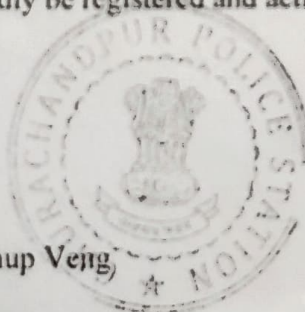
