





On 16/09/2023 at about 9.20 pm a large number of unruly mob including male and female numbering about 1000/1500 were entered towards Porompat Police Station Campus and they started shouting and attempt to break the main gate of the Police Station. In that the Police personnel warned to the unruly mob to turn back from PS campus. But the unruly mob became more violent and forcibly entered inside the PS campus and also pelting stone towards the Police personnel as well as Office room. That, the duty magistrate Imphal East who was on duty ordered to disperse the unruly mob by using minimum force like tear gas shell smoke bomb etc. Accordingly, the Police personnel of Porompat Police including Commando Imphal East, SDPO/PRT, Oscar-87, RAF and SSB dispersed the unruly mob by using tear gas shell, smoke bomb as well as firing several rounds in the air. The unruly mob was dispersed at about 2.30 am of 17/9/2023. During mob dispersal, there was no any human casualty or damaged.

Hence a regular case under case FIR No. 1235(09)2023 PRT-PS u/s 147/148/149/353 IPC has been registered on suo motto for investigation.
