

Today i.e. 19/9/2023 from 11 am, large number of bandh supporter regarding 48 hrs Bandh called by 27 joint Club of Manipur w.e.f. midnight of 18/9/2023 in c/w the arrest of 5 persons are gathered and blocked the road in and around Porompat Jurisdiction area i.e Porompat DC Road, Top Khongnangmakhong Road, Ayangpalli, Lamlong, Tinsid Road, Konungmamang, Tellipati and Wangkhei Ayangpalli Kongba Road etc. That, the bandh supporters are disturbing to the general public by blocking the roads and burning tyres. That, the Police teams of Imphal East warned them repeatedly not to block the roads, but the bandh supporters became more violent by pelting stones towards the Police teams on duty. They also destroyed some Government properties i.e. Office signboards.

Hence a regular case under case FIR No. 1238(09)2023 PRT-PS u/s 147/148/149/341/353 IPC & 3 PDPP Act. has been registered on suo motto for investigation.
