

Sir,

I have the honour to report that today ie 20/9/2023 from 2:00 pm to 8:00, I was detailed for law and order duty at Lamlong Bazar by OC of Store Imphal East. After completion of my duty, I was proceeding towards my home along the Lamlong Ukhrul road riding on my two wheeler Honda Activa is being intercepted at Chairenthong by unknown 05(five) persons wearing Khaki uniform (police uniform/dress) in a four wheeler vehicle Bolero (white) and forcibly snatched away a sum of Rs. 15,000/- (fifteen thousand) from my wallet on the same day at about 08:30 pm. And then I was blindfolded and assaulted by five of them using abusive language.

It is, therefore, requested to kindly to take up necessary legal action against those perpetrators according to law.
