They are also blocking security vehicles on duty, thereby using criminal force to deter public servant from discharging their duty. Inspite of giving several warning not to proceed towards Porompat PS, the unruly mobs did not pay heed. Rather, they resorted to pelting stone and attacked by using slingshot/catapults to the security personnel. In that, some personnel of the District Police and other unit of security personnel were received injury on their person. In the meantime, the Executive Magistrate who was on duty at the spot order to dispersed the mobs. Accordingly, the District Police and Paramilitary forces, RAF, C/9 BSF, 4th AR Women, and 88th Mahila BN CRPF Langjing had fired several rounds of Tear Gases, Smoke Shell to disperse the mob.
