

Sir,

I, the undersigned have the honour to state that large number of innumerable unidentified groups of people belonging to the Kuki community with deadly weapons and sophisticated arms including Kuki militant group(s) stormed the Meitei inhabited area(s) of Moreh town on 3rd May, 2023 at around 4:30 P.M. The said unidentified groups looted all valuable items. In that unfortunate incident, I have lost a total amount of about Rs. Seven lakhs fifty thousands (7,50,000.00) only. After that said unfortunate incident/mob violent, my family left Moreh and is now taking shelter at a relief camp 3-Khurai Imphal East District, Manipur.

It is, therefore, my prayer that respected Sir may kindly initiate and take necessary legal action(s) against the accused people and the persons involved in the said inhuman acts and heinous crime as per the law of the land as early as possible.

I shall forever be grateful for your kind cooperation and necessary action(s).
