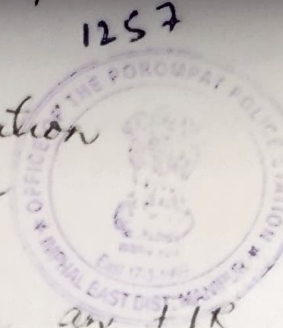

I therefore request your honour to kindly lodge an FIR against these unknown miscreants and punished according to the law of the land.
