

Sir,

I, the undersigned have the honour to state that large number of innumerable unidentified group of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki Militant Group(s) stormed to all Meitei inhabited areas of Moreh town on 26/7/023 from 10 am till 4:30 pm . The said unidentified groups vandalized / burnt down my house cum Hotel named as K.M.P. Hotel and looted all valuable items. In the unfortunate incident, I have lost a total amount about Rs. 12,50,000/- (Rupees Twelve Lakhs Fifty thousands) Approx. That, the incident was begin from 3/5/2023. So, I and my all family members are taking salter at permanent address Nongmeibung Ayangpalli Road, Manipur. That, the incident was happen while I and my family were staying at my permanent address.

It is, therefore, requested to kindly take necessary legal action against the accused persons and the persons involved in the said inhuman acts and heinous crime according to law.
