orompat Police Station Imphal East, Maniput about 12.30 pm some students of CC Higher Secondary School & Ananda Singh Higher Secondary Academy numbering about 300/400 came out from School campus along Konungmamang Sanjenthong road and organised a rally and started slogan against the brutal killing of two student by Kuki millitant. Accordingly team of Imphal East District Police led by SP-IE and RAF rush to the Konungmamang & Sajenthong area. The Police team has repeatedly warned to the students to return their respective schools. Howevere student become more violent and pelted stones towards the security personnel who were on duty at the spot thereby causing injury to some Police personnel. In the meantime, Executive Magistrate Imphal East on duty at the spot order to use minimum force like tear gas shell to disperse the student's mob. 'Accordingly, Police personnel dispersed the mob using tear gas shell. During the dispersal of the mobs, some students might receive injury due to stamped.

Hence, it is considered to initiate a case and accordingly registered a regular case under FIR No. 1268(7)015 PRT-PS u/s 147/148/149/353/325 IPC and has been registered on sou mutto for investigation.
