

The said unidentified groups vandalized my house located at prem nagar loubuk
leikai Ward No.5 and looted all valuable items . In the unfortunate incident, I
have lost a total amount about Rs. 4000000/- (Rupees Forty lakhs) Approx. .
That, the incident was begin from 3/5/2023 . So, I and my all family members
are taking salter at relief camp situated at Kongpal Kongkham Leikai, (Khurai
3) Imphal East District, Manipur. That, the incident was happen while I and my
family were staying at the said relief camp.

It is, therefore, requested to kindly take necessary legal action against the
accused persons and the persons involved in the said inhuman acts and heinous
crime according to law.
