Subject :- Report.

Sir,

I, the undersigned have the honour to state that today i.e. 27/09/2023 at about 7.30 pm I along with my team including my Officer SDPO-PRT and other teams of Imphal East District Police rushed to the residence of Mrs. A. Sharda Devi, President of BJP, Manipur located at Bamon Leikai, Imphal East District for controlling unruly mob created by the public in c/w brutally killing of two students by the Kuki militant. While Officer and others team are controlling the mob at Bamon Leikai, I was on the vehicle (Gypsy) bearing regd. No. MN01W-9989 which was allotted to the SDPO-PRT. Suddenly, the unruly mob was approaching towards the vehicle and started pelting stone. In order to save myself, I was driving towards New Thumbuthong bridge. However, the unruly mob chased me upto Loklaobung near Bormani Workshop and pulled me out from the vehicle and assaulted me with an attempt to kill me. Further, they forcibly snatched my service gun (9 mm pistol bearing No. 18357407 having one magazine loaded with 10 live rounds) and burnt down the vehicle (Gypsy) including wireless set bearing SL No. 038TMC9968 which was installed with the vehicle. Fortunately, I was saved by other Police teams of Imphal East and Imphal West District but I received serious injury on my face, nose and other parts of the body.

It is, therefore, requested to kindly take necessary legal action against the agitator according to law.


