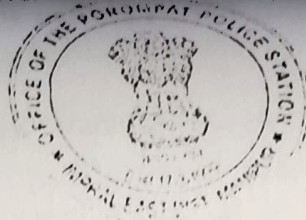

In the meantime, I run out from my room and intercept and intervene them not to enter. I also heard many peoples were shouting abusive language outside my gate and pelting stone and attacking by using slingshot/catapults and deadly weapons and attempt to kill me and my family. They also damaged the cable wire of my CCTV which installed in my main gate of the gun house.

It is, therefore, requested to kindly to take up necessary legal action against those persons as per law of the land.
