Sir,

I, the undersigned, have the honour to lay down the following few lines for your kind perusal and necessary action(s) pleased.

1. That, I am a doctor by profession and I have been running a Diabetis Hospital in the name & style of Diabetis Healthcare and Reserch Centre at Porompat Soibam Leikai, JNIMS Road, near Punjab National Bank, Imphal East, Manipur.
2. That, on 30/09/2023 at about 4:15 p.m. three unknown persons of one unlawful organisation, PREPAK-(Pro) introduced by themselves, came to my said Diabetics Hospital and then threatend and demanded a huge amount of money for buying 3 (three) sophiscated guns/ weapons and 500 (five hundred) live rounds of gun bullets to me in front of my staffs.
3. That, the said three unknown persons of the so-called PREPAK-(Pro) had also threatened to kill me in case of failing to fulfil the abovesaid demands within 10 (ten) days.
4. That, in the similar matter, on 11/09/2023 I had already lodged a written complaint to the concerned authority(ies) and/or the police station for taking necessary legal actions against the persons involved in the illegal acts.

It is, therefore, prayed that the respected Sir may kindly initiate and take up appropriate necessary legal action(s) against the person and/or the persons involved in the matter and kindly provide necessary security for the protection of my life as well as the diabetis hosital for avoiding any untoward incident in future.
