

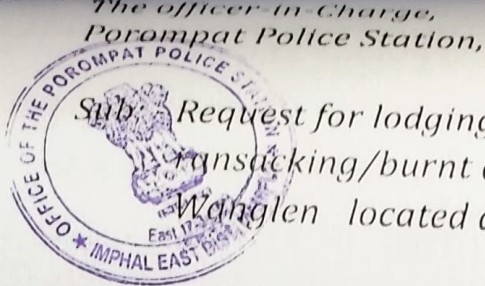

Wanglen located at Moreh on 3rd may 2023.

Sir,

I, the undersigned have the honour to state that large number of innumerable unidentified group of people belonging to Kuki Community with deadly weapons and sophisticated arms including kuki militants groups stormed to all Meitei inhabited areas of Moreh Town on 3rd may 2023 at around 4.30 pm. The said unidentified groups vandalized/burnt down my Hotel title as Hotel Wanglen located at Moreh Ward No. 6 Tali Road and looted all valuable items. In that unfortunate incident, I have lost a total amount of Rs. 5000000/- (Rupees Fifty lakhs).

It is, therefore, prayed that the respected sir may kindly initiate and take necessary legal action(s) against the persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law of the land as early as possible. I would not report the matter timely due to present situation in the state.

I shall be grateful for your kind co-operation and necessary action (s).
