Subject - Report on crimes of vandalism, looting, arson-attack, criminal intimidation, unlawful displacement and discrimination of Scheduled Tribes.

Dear Sir.

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the *Thadou-Kuki Tribe*, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, I am a caretaker(chowkidar) of Kuki Baptist Church (KBC), residing at caretaker(chowkidar) Quarter located at New Lambulane, *P.O. & P.S.- Porompat* and District-Imphal East. Due to the prevailing ethnic crisis in and around Imphal, I along with my family left our above-mentioned resident on the 3rd of May, 2023 at around 9.30 PM, it has come to our knowledge that our deserted house was attacked, destroyed and arson attack by a Group of radical Meeitei/Meiteis suspected to be members of Arambai Tengol and Meetei Leepun on the 5th of May, 2023 at around 9:00 PM.

The criminals broke open my door, destroyed and looted every valuable property from my house/ premise's worth about Rs. 20,90,000/- (Rupees Twenty Lakhs Ninety Thousand) only. And, along with the properties my 2(two) Two-Wheeler i.e, TVS Ntorq (red&black) & Mahindra Duro (red) which was also torched by the said miscreants, and whereas, the regn. No. and other details are inside the trunk of the mentioned vehicles.

That, it may be reported here that the miscreants were shouting slogans like-"KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.
