Subject :- Report on Looting, Vandalism and burning down of house, household item/assets.

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I **Deborah Kimneichong** aged about 31 years W/o **Haolenlal Haokip** Belonging to the **Any-Kuki Tribe / Community**, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a permanent resident of **New Lambulane 3rd Street Imphal West P.O&P.S., Porompat**.
2. That, due to the sudden escalation of ethnic clashes between the Meitei and the Kuki-Zo communities in Manipur, I along with my family fled from our house and took refuge at **Leimakhong A.R Camp** For our own safety, leaving behind our house and property.
3. That, on the **27th of August 2023** at around **1:30 Pm** some radical Meitei suspected to be a members of **arambai Tengol** and **Meitei Leepun** who entered from our neighbour's **Bhim** compound attacked those house belonging to the **Kuki-zo** community by looting our house then eventually burning them down using petrol bomb.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred a huge loss which may be estimated to be **Rs. 70,00,000 (Rupees Seventy Lakhs)** only
4. Fortunately, me and my family managed to escaped before the incident took place and now currently taking refuge at **Tuibong Churachandpur Manipur**.
5. That, I am filing this information lately because there is a great danger to my life, and due to which I was at different places to save my life. And now, I am able to restore my health and settled at **Tuibong Churachandpur**. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an **FIR/ZERO FIR** , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
