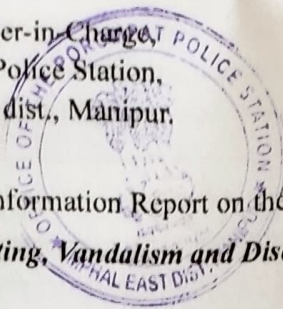

Subject: - First Information Report on the crimes of *Criminal Intimidation, Unlawful Displacement, Looting, Vandalism and Discrimination of Scheduled Tribes.*

Respected Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the *Any Kuki Tribe*, a recognized Scheduled Tribe under the Constitution of India. And, we rented a house owned by *Hassan (8416000926)* located at *Hatta Golapati, New Checkon, P.O. & P.S.- Porompat* and district- *Imphal East-795002, Manipur.*

That, due to the prevailing ethnic crisis in and around Imphal Valley, our family deserted our above-mentioned resident on the *4th of May, 2023* at about *4:30 AM*, we took refuge at *1st Manipur Rifles, Old Lambulane, Imphal East.* And, on the *15th of May, 2023* at around *6:30 PM*, a group of armed Meitei/Meitei suspected to be members of *Arambai Tenggol* and *Meitel Leepun* looted and vandalized our properties.

That, it may be reported here that the miscreants were shouting slogans like- "*KANGLEIPAK YAIPHARE*"; "*KUKI HATLO*"; "*HAO HATLO*"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.

That, it may also be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be *Rs. 9,64,200/- (Rupees Nine Lakhs Sixty-Four Thousand Two Hundred)* only.

That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today.
