With reference to the above cited subject, I have the honour to report to you as follows. Manipulation of the subject of the s

- 1. That, I Shri Khamsianmuan aged about 47 years, S/o (L) Demgo, belonging to the Mizo tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989. and that, I am a permanent resident of Mission Road, Lamka, P.O./P.S.& District Churachandpur, Manipur -795128.
- 2. That, I was previously posted at Presbyterian Church New Checkon, Imphal East as Field Secretary, Presbyterian Mission Field, Since 2020 till the date of incidence mentioned here-in below.
- 3. That, on the 3rd of May 2023 at about 8:00 pm, upon the escalation of ethnic conflict between the tribal and the majority Meetei Community, me and my family were compelled to take refuge at the house of members from our local church belonging to the Meetei community till the 5th of May, 2023 and at about 4:00 am, of the 5th of May we were being escorted to Imphal Tulihal Airport with help from the said members from the Meetei community from our churches from whence I was flown to Shillong and from there-on I was back to my Native place @Mission Road, Hiangtam Lamka, Churachandpur Manipur Via Aizawl, Mizoram.
- 4. That, on the 11th of July, 2023, I was informed by resident of the said locality in Imphal, that a huge contingent of armed radical Meeitei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun have looted, vandalized all my personal assets/property which was within my residential quarter situated at New Checkon, Imphal East, P.O./P.S. Porompat, Manipur.
- 5. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs 20,00,000 (Rupees Twenty Lakhs) only.
- 6. Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at Mission Compound, Lamka, Churachandpur Manipur-795128 at a rental room.
- 7. It is pertinent to mentioned herein that due to fleeing from my place of residential quarter to my current native/refuge places due to the on going enthnic clashes between the Majority Meetei and the tribal populace, there has been delayed in filing of Zero FIR.

In the given circumstances, I humbly pray you to kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
