With reference to the above cited subject, I have the honour to report to your good office as follows:

That, I Mr N.Ngamkhopao Baite aged about 49 years S/o (L) Jangthang Baite belonging to the Any Kuki Tribe, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989.**

That, I would like to inform and register a cognizable offence carried against me and my family at own house located at New Lambulane river bank, Imphal East District. P.S- Porompat.

That, on the **9th of May, 2023** at around **11:00 AM**, a huge contingent of armed radical Meeitei/Meitei suspected to be members of the Arambai Tenggol and Meetei Leepun attacked our locality and fearing for our lives we fled to **1st MR Police Camp** for our safety, from thereon we fled to Shillong via Kangpokpi.

That, it may be reported that from a reliable source, our properties from the said deserted resident has been looted by the said criminals activities which have caused grave mental agony and incurred huge loss which may be estimated (approx.) to be **Rs 10,00,000 /-** (**Rupees Ten Lakhs**) only.

Fortunately, me and my family managed to escaped with the help of Central Forces from these criminals who even tried to kill us, and now currently taking refuge in relative house at District Headquarter Tuibong, Churachandpur, Manipur

I am filing this report lately since I have been at different places for safety. Now, since I am able to settle myself at the above mentioned address, I am in a position to file a report today. Hence, prayed that my report be accepted.

In the given circumstances, I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of the land. And, for which act of kindness, I shall always remain thankful to you and obliged.
