Request for lodging FIR regarding looting of household assets and vandalized/burnt down of my house located at Moreh Ward No. 7.

Sir,

I have the honour to lay the following few lines for your kind information and necessary action on the above cited subject.

That on dated 26 July, 2023 of around 4:30 PM a large number of people of Kuki Community leaded by Sh. Letpao Haokip, Hon'ble M.L.A. of Tengnoupal Constituency along with Kuki militants group viz. K.N.O/K.N.A. holding deadly heavily weapons and sophisticated arms have looted all my valuable household assets and vendalized/burnt down the same house. The brief description of my house is furnished as under. The house was built by wooden structure with ekra walling, and C.G.I. roofing having four rooms and front varandah. They have looted 15 mond of paddy, gold jewellery, wooden Bed (3 Nos.), T.V. (1 No.), stand fan (1 No.), LPG Cylinder (3 Nos.) & Gas stove (1 No.), Kitchen utensil, bed materials and clothes, Cash money of Rs. 70,000 /-, radio set & cycle. I have lost a total amount of Rs. 15,00,000/- (Rupees fifteen lakh) approximately in that unfortunate incident. After the outbreak of clash/war, I was fled/run from Moreh and at present I am staying with my uncle and my grandfather who was staying together with me before the clash/war was still in KMP (AR camp) Moreh as I heard from those who fled from Moreh. But, I could touch with him till now.

It is therefore requested to your goodself to kindly initiate necessary legal action against the accused persons/culprits involved in the said in human acts and heinous crime committed by them as per law of the land at the earliest.

I shall be very grateful for your kind co-operation and necessary action in the matter please with warm regards.
