Sir,

I, the undersigned, have the honour to state the following for your kind  
intervention and favourable action praying for registering an FIR and investigate the  
matter by due process of law:

1. That, I Shri Lalsiem Chongloi S/o Letthenlal Chongloi, aged about 26 years,  
belonging to the Kuki community, a Schedule Tribe recognized  
under the Constitution of India, by virtue of which I am entitled to the  
protection under **The SC/ST (Prevention of Atrocities) Act, 1989.**
2. That, I am a permanent resident of Teiseng Village, P.O./P.S. & District  
Churachandpur, Manipur-795128.
3. That, on the 4<sup>th</sup> of May 2023, I temporarily settled at Imphal seeking Medical  
treatment however, due to the atrocities of some armed radical mobs  
belonging to meitei/meitei community spearheaded by Meetei Leepun and  
Arambai Tengol armed with sophisticated weapons, accompanied by state  
forces posted at various valley based police outpost against Tribal Community  
I was taking force to flee and took shelter at Shri P DOUNGEL (Former DGP)  
while my vehicle of Maruti Suzuki Make, Ecco Model Bearing Reg No.  
MN06LA 4243 which was park outside beside the road was gutted/burnt, the  
said vehicle was estimate to be valuated at Rs. 5,10,000/- approximately  
(Rupees Five Lakh Ten Thousand) only.

That, in view of the above stated facts and circumstances, being a victim of a  
communal/ethnic clash spearheaded by the majority meitei/meitei community, I am
