Sir,

I SI, Letminlal Suantak of CCP-PS would like to report that in the evening of 03/04/2023 at around 7:30 pm mob from Meitei community forcefully attacked my house at Newlambulane 3<sup>rd</sup> Street Junction, Imphal East. The attacker were armed with guns and sharp weapon. They destroyed every household items and burned the house while my family were still inside the house. Luckily, my wife and children managed to escape from the house and attacker but they were subjected to horrific act of terrorism from the Meitei community.

Particulars of the articles loss, burned or damaged:

1) Honda Activa MN01U-2018 2) LED TV 3) RO 4) Samsung Fridge 5) 4 Almirah 6) 1(one) Wooden Almirah 7) Kitchen almerah 8) Electric Chimney 9) Dining table 10) Sofa Set 11) TV Cabinet 12) wooden drawer 13) Sintex, 14) 3(three) Bed 15) Documents, etc.

Total value of destruction cannot be ascertained as of now. I cannot report the matter in time due to the prevailing situation and continuous duty engagement. I am lodging this complaint against the unknown criminal for attempted murder, arson, looting and ransacking of my house, property and valuable documents.

I therefore urge you to take swift action and bring these criminal to justice. These heinous crime have left me and my family in trauma and unsafe in my own state Manipur.
