I am to bring to your notice that on 3rd May, 2023 between 7:30pm -8pm, my rented house located at New Checkon, Imphal East was attacked by a group of Meitei goons.

The said goons broke my gate, destroyed my Swift car bearing regd. no. MN 04P3262 and entered my house by forced, and destroyed my house-hold properties with an estimated cost of 12,00000 (12 Lakhs approx.).

Fortunately, I myself, my wife and my son managed to escape from the culprits.

Therefore, with utmost respect, I request you to take strong action against the perpetrators by registering an FIR under relevant section of the Indian Penal Code.
