Subject – Report on vandalism, looting and burning of properties on (movable)

Sir,

I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo) and a resident of Nongmeibung Leikai, Porompat, Imphal West.

That, on the 3<sup>rd</sup> of May, 2023 at around 7p.m. my above said residence (Rented) was attacked, destroyed, looted and burned by a Group of Meeitei/Meitei radicals.

These criminals broke/open my gate(s), destroyed and looted every valuable property from my "Rental" House, and premises worth Rupees 240,000/- (Approx.) and they burnt down all the remaining things.

That, My Cosmetic Shop No. 34, 35 & 36, located at Tribal Market, New Checkon, Near Winger Parking, Imphal East, was also Looted by the above mentioned radical mob, The rates and valued of the properties in my shop Amount' to Rs. 400,000/- (Approx.)

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/ Zero FIR under relevant sections of the statutes of our country.
