

**Subject:- Report on vandalism and looting of my Grocery shop located at Chasat Avenue, New Checkon, Imphal, P.O & P.S- Porompat & District- Imphal East on 25-05-2023.**

Sir,

With due respect, I the undersigned would like to make a report to your good office about vandalizing and looting of my Grocery shop under the name and style of Hmar Variety Store located at Chasat Avenue, New Checkon, Imphal, P.O & P.S- Porompat & District- Imphal East on 25-05-2023 by a group of Meeitei/Meitei's along with some women numbering 500 to 600.

At the very outset, I would like to draw fewline for your information that due to the present situation of ethnic class between Tribal and Valley base Meitei/Meeitei from 03-05-2023, on dated 25-05-2023 the lock of my shop was destroyed by a group of Meeitei/Meitei's, they vandalized and looted all the Grocery items (stock inside the store) and with Deep Freezer (2) in which I used for storing ice cream and some other items which worth Rs. 13,50,000/- (Rupees Thirteen Lakh and Fifty Thousand) on the said day.

It is requested to your good office to make entry of my report a Zero F.I.R and take action against the perpetrator as per Law and also issue me the copy of the said report for my reference in future
