I and my family were residing in the above address since 44 years. On the 3rd, May, 2023, at around 5:00 Pm, group of Meitei mob started attacking our locality in which they attempted to burn down the house 3 to 4 times, but in vain, yet they failed. On 7th of May, 2023 we fleed from our village and fleed to the MR Camp and from their we moved to Kangkopi and stayed their in the camp for almost one month and then moved to Shillong. After we left they managed to loot the house and all our possessions that were there in the house.

I had to flee because I heard that my tribe was under attack and since I was also a Kuki, we no longer found it safe and we feared for our life. I had possessions including electronics, vehicles and jewels worth Rs. 1,40,00,000/- in my house and I have no idea if anything is left after the theft by the mobs.

I have 3 children and they all were studying in Schools and now their studies have been disrupted and we have no idea when things will go back to normalcy. I was working as a teacher in Lower Primary School and I now no longer have has a job. I don't know how will I again feed my family.

Due to this incident I and my children have been put to great hardship and mental trauma.

Hence, I request that you will investigate the matter and take proper action against the perpetrators as well as restore the situation to normalcy and provide protection for us to go back and re-build our lives back in our locality. We request that you will also protect our properties and the whole locality from encroachment.

We are hoping for Justice for us and for all who are in this situation.
