Respected Sir,

I have living in the above address since six years and the house belonged to my uncle. Around 12:00 PM I heard the local alarms ringing indicating danger. Hearing that I went out to check what was happening, there were munipur police commandos but all the residents had fled. When I asked them about the situation, they said that nothing had happened and sent me back home. Out of panic attack due to the sound, some residents were shouting in the locality. Then I realised something is going to happen. Hence, I attempted to flee from the house but the commandos stopped me. I still managed to escape from my house without taking anything in my hand. I fled to a nearby house which belonged to Ex MP and took refuge there. After 5 minutes, state sponsored terrorists Aramboi Tengol dressed in black and Meitei Leepun led by Manipur police showed up in our locality by shouting with a roaring voice commanding all the Kukis to be killed. Their words and voices traumatised us.

Within 5 minutes, I heard sounds of houses burning and thundering sounds of gas cylinders everywhere. When I peaked out of my hiding, our locality along with my house was completely burned down and full of smoke and sound. Later the police asked us to move out saying that they won't be able to help. And then I rushed towards First MR for shelter and stayed there for 3 days. From there fearing for our lives we went to airport with the help of the Para Military and 3 stayed for 3 days. From there we moved to Shillong.
