We are the residents of the above address for the past eight years. On the 4th, May, 2023, I went by myself with my nine-months pregnant wife to 1st Battalion Manipur Rifles for safety and shelter. And we were staying at the Camp for almost a week. On the 9th May, 2023, the Manipur Rifles took us to the airport and flew us to Guwahati and then we went to Shillong. After we left Haokip Veng, the Arambai Tengol and Meitei Leepun led by Manipur Police attacked the locality and burnt down the houses and looted the properties. My properties which were being damaged by the miscreants were amounted to Rs. 8.50 Lakhs (Eight Lakhs Fifty Thousand Rupees)

Hence, we request you to transfer my posting to my home district at Churachandpur.

We are hoping for Justice for us and for all who are in this situation.
