Respected Sir,

We are the resident of the above address since 1960. On the 4<sup>th</sup> May 2023, around 12.00 in the afternoon while we were having lunch, the atmosphere was filled with sounds of tear gas and gun shot alongwith sounds of ringing electric post (signal of an alertering situation). Haokip veng is a locality nearby All India Radio Imphal and Chief Minister Bungalow, therefore we were not so much alertered as the locality has been surrounded by Manipur police on all sides. However one expectation about the security personnel was in vain. Our locality seemed to be the most insecure places in a blink of an eye, roads filled with rushing sounds. We came to police posted nearby our house to inquire but forced us to remain inside our house saying that curfew has been imposed.

calls from phone one after another about localities attacked, vandalised and burnt. We managed to escape from the Police who was posted nearby and fled to the house of former ex M.P Halkhomena Hack. Many of us assembled there. Our only hope was in the Almighty God, we held a mass prayer. Later after 10 minutes, State Sponsored terrorists shouting "lets Kill Kukis" arrived led by Manipur Police Commandos. The Roaring even traumatised us, tear gas and gas cylinders exploded from burnt houses. Our church was burnt down. We were left with no choice. The Manipur Police came to our hiding place and asked us to come out, told us that they won't be able to help us out as the miscreants are great in number. We were targeted so they did not want to help us out. How can Govt security less than mob, if they really wanted to help us, there will be a way. From there we headed to 1st Manipur Rifle Battalion and took a refuge there. Even at 1st MR we felt insecure, no proper foods, water and sanitation.

as we were not carrying anything from our homes. The only safest way is to leave Manipur. After 2 nights of staying in 1<sup>st</sup> MR, we headed to airport for staying before our tickets were confirmed.

On reaching airport we were quite relieved while seeing avenues posted at airport. Not only one family were relief on reaching airport, there were kids longing to return home but there was no reason because our houses were burnt down and looted by Meeteis in broad daylight. We stayed there, slept on the floor and left for Shillong. Even after reaching Shillong, one Meetei tried to leave us, now.
