I and my family are living in the above address since 2006 on rent. On 3rd May we got attacked and our house was vandalised by the Meitei Leepun mobs and Arambai Tengol, who were armed. We had no choice but to flee take shelter in muslim community at Golapati and moved to 2nd MR Relief Camp the next day and stayed there for 5 days. Then by flight we moved to Guwahati and then to Shillong. Due to the sudden attack we weren't even able carry a pair of spare cloths nor things for our basic needs. I am daily wager and am no longer able to find a job nor earn money to take care of my family. I have 5 children of which 2 are still pursuing their studies in Imphal and the other 2 are also being taken care by me. Due to this incident I am left homeless and all my material possessions have been vandalised.

I know that my house was targeted because we belong to the Kuki tribe and the ethnic cleansing by the Arambai Tengol alongwith State Force Commandos. Due to the attack I have lost my material possessions worth Rs. 10,00,000/-.

Due to the displacement, me and my family have gone through terrible losses financially and are suffering from mental trauma and are left with no hope right now.

Hence, we request you to restore the situation to normalcy and help make good the financial losses we have faced.

We are hoping for justice for us and all our people from this situation.
