

Subject. **Report on Criminal Intimidation, Sedition, Attempt to murder, promoting enmity between community, disturbing public tranquility.**

Madam,

I, the undersigned, have the honour to state the following for your kind intervention and favourable action praying for registering an FIR and investigate the matter by due process of law:

1. That, I Mr. Lalkhawthang S/o Luma, belonging to the Hmar tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989.**
2. That, I am a permanent resident of Hmar Veng, P.O./P.S. & District Churachandpur, Manipur-795128.
3. That, on the 3rd of May, 2023 I went to visit my niece who was hospitalized at Jawaharlal Nehru Institute of Medical Science, situated at Porompat Imphal East, Manipur. While on my way home from the said hospital I was stopped by a large mob who armed themselves with weapons such as stick, stones etc. Fearing for my life I ran inside Moirang Police Station, hoping that at least I would be safe within the armfold of states' law enforcement agency. However, to my awe and surprise the said mob was able to gain access inside the said Police Station, and I was dragged onto the road and was beaten with an intent to kill. After I was unable to move and lying lifeless on the open road I was left alone for my fate.
4. However, fortunately I am able to survive the haunting tragedy despite the hurdles and against all odds, with the help of tribals police personnel who got posted at Moirang Police Station I was able to reached Churachandpur and got admitted at Samaritan Hospital Tuibuong, Churachandpur, Manipur-795129.

That, in view of the above stated facts and circumstances, being a victim of a communal/ethnic clash spearheaded by the majority meitei/meitei community, I am filing this report with a request to kindly take necessary legal action against the perpetrators as per law.
