That, at about 11:00 am on the 4th of May 2023, some armed radical mobs belonging meetei/meitei community armed with sophisticated weapons, chanting anti-tribal slogan, barged im my rental room situated @ Haokip Veng, P.O./P.S. Porompat, Imphal East, Manipur-795005, ar the said mob vandalized, looted, burnt/gutted all my household items/assets, a total loss estimated to be at an an amount of Rs. 15,00,000/- (Rupees Fifteen Lakh) approximately.
 - Fortunately, me and my family managed to escaped from these criminals who even tried to kill of burn us alive, and now currently taking refuge at Laizon Veng, Tuibuong, Churachandpur-795128.

Being a victim of ethnic attack by the dominant and majority Meiteis, I am filing this report on behalf a my cousin, with a request to kindly take necessary legal action against the perpetrators as per law.
