Fortunately, me and my family managed to escaped from these criminals who even tried to kt burn us alive, and now currently taking refuge at Mongkof Chopi Copur. In the given circumstances, I humbly pray you to kindly register an FIR/ZERO FIR, investigat matter and punish the perpetrators as per the prevailing provisions of the laws of our country.
